As president of the professional jury, for what do you call the attention of the prospective applicants?

It is important to highlight the application criteria that you may only apply for a product, software or service which have already been introduced and are available to users. In addition, it is necessary for the submitted product and service to be fully compliant with the legislation and the relevant quality requirements. When compiling an application, it is important that these supporting documents would be submitted. For a positive evaluation, it has to demonstrate market value of the product/service in the application in a very clear and understandable way. Applicants must be able to clearly understand the benefits of their own product and service and these must be also presented in the tender dossier submitted. One of the advantages of Value and Quality Award Tender is that it provides free consultancy for applicants. I suggest you to take advantage of this opportunity for submitting a successful application.

To whom are you offering to submit an application?

We are waiting applications from businesses attaching a great importance to high quality products/software and services. The main tender categories included in the call for proposals cover the entire market spectrum, so in fact all product manufacturers, software developers and service providers can submit their application.
